RESOLUTION:

The Government of Gujarat has constituted the Gujarat State Law Commission under Government Resolution, Legislative and Parliamentary Affairs Department No. LAC/1098/27/E, dated the 22nd December 1998.

2. The Government of Gujarat hereby appoints the Hon. Chief Justice Dr. J. N. Bhatt (Retired Chief Justice, High Court of Patna) as Chairman (full time) on the vacant post of Chairman of the said Commission.
3. The terms and conditions of the appointment of Hon. Chief Justice Dr. J.N. Bhatt (Retd.) as the Chairman of the Commission shall be as under:-
 - (i) He shall be paid by way of monthly remuneration for acting as Chairman of the Commission, such amount as is equal to the salary of a Chief Justice, High Court in addition to the pension and allowances being already drawn by him as Chief Justice of High Court.
 - (ii) He shall be entitled to all such benefits and privileges as are attached to the office of Chief Justice, High Court till the date he holds the office of the Chairman of the Law Commission.
 - (iii) Hon. Chief Justice Dr. J. N. Bhatt, (Retd.) the Chairman of the Gujarat State Law Commission shall be entitled to the pay, all allowances and benefits such as facility of rent free house, leave travel concession, conveyance allowances, electricity charges, telephone charges, news papers and magazine charges, facility of residential attendance, facility of medical treatment, entitlement of leave, compensatory allowance, personal security guards, computers etc. as are available at present to the sitting Chief Justice of Gujarat High Court and that may be available from time to time in future.
 - (iv) He shall hold office up-to 31st December, 2011.
 - (v) He shall be entitled to subscribe to the Contributory Provident Fund from the date of re-employment as per the Government Orders issued in this behalf from time to time.
4. These orders shall take effect on and from the date on which Hon. Chief Justice Dr. J. N. Bhatt (Retd) assumes his office as the Chairman of the Commission.

5. The expenditure shall be debited to Budget Head "Demand No.62, Major Head 2052-Secretariat-General Services-Sector-A-General Services-Sub-Sector(d), Administrative Services, Minor Head-090-Secretariate, Sub Head(3), State Law Commission" and be met from the grants sanctioned there under.

6. This issues with the concurrence of the General Administration Department vide its note dated: 3 -12 - 2008, and Finance Department vide its note dated: 20-11-2008, on this Department file of even number.
