RESOLUTION:-

1. Consequent upon the appointment of the Honourable Justice Mr. M.B.Shah (former Judge of Supreme Court of India) as the Chairman of the Gujarat State Law Commission, Mr. Justice M.B.Shah has taken over the charge of the Chairman of the Commission with effect from 02/01/2014.
2. The Government of Gujarat is pleased to decide the terms and conditions of the appointment of Mr. Justice M.B. Shah as follows:-
 - (1) He shall be paid a lump-sum monthly remuneration of 1.25 Lakh per month till he holds the office of the Chairman;
 - (2) He shall be paid Rs 25,000/- per month in lieu of government accommodation as a special housing allowance;
 - (3) He shall be entitled to an official car and cellphone facilities. The official car will carry fuel entitlement as the scale as is given to the Chief Justice of the High Court of Gujarat;
 - (4) He shall not be entitled for any other allowances;
 - (5) He shall be entitled to 12 casual leaves during the year. He shall not be entitled for Earned Leave. Since he is not entitled for E.L., he shall not be entitled for Leave Encashment;
 - (6) He shall not be entitled for the facility of L.T.C.;
 - (7) He shall be entitled to the facility of medical treatment on a scale as is given to retired Judges of the Supreme Court. He shall have the option of claiming reimbursement either from Government of Gujarat or from Government of India (As retired judge of the Supreme Court).
4. The Headquarters of the office of the Gujarat State Law Commission, headed by Justice Mr. M.B.Shah, shall be at Ahmedabad in Bungalow No.14, Dafnala, Shahibaug, Ahmedabad.

5: In the Government Resolution, Legislative and Parliamentary Affairs Department No. LAC/2006/44/110/Law Cell, dated the 31st December, 2013, in para 2, the brackets and words "(full time)" shall be omitted.
