- 3. The terms and conditions of appointment of Justice Shri Dipakbhai K Trivedi as the Chairman of the Commission shall be as under:
 - (i) He shall be paid by way of monthly remuneration for acting as Chairman of the Commission, such amount as is equal to the salary of a High Court Judge reduced by the amount of pension sanctioned to him.
 - (ii) He shall be entitled to all such benefits and privileges as are attached to the office of High Court Judge till the date he holds the office of the Chairman of the Commission.
 - (iii) He shall be entitled to a staff car with a driver and reimbursement of the value of 200 litres of petrol every month or the petrol actually consumed in the car, whichever is less, as entitled to the High Court Judges under section 22-B of the High Court Judges (Conditions of Service) Act, 1954.
 - (iv) He shall hold office upto 31st December, 2007 from the date of appointment.

- (v) He shall be entitled to subscribe to the contributory Provident Fund from the date of re-employment as per the Government Orders issued in this behalf from time to time.
- 4. These orders shall take effect on and from the date on which Justice Shri Dipakbhai K Trivedi assumes his office as the Chairman of the Commission.
- 5. The expenditure shall be debited to Budget Head "Demand No.62, Major Head 2052 Secretariat-General Services, Sector -A General Services Sub-Sector (d), Administrative Services, Minor Head 090 Secretariat, Sub Head (3), State Law Commission," and betweet from the grants sanctioned thereunder.
